The Chairman welcomed all the members present for the meeting. The following were discussed and resolved:

1. Principal informed the members that three new PG Programs of Thermal Engineering in the Mechanical Engineering Department, Control Engineering in

the Electrical & Electronics Engg. Department and Structural Engineering in the Civil Engineering department each with an intake of 18 were started during the academic Year 2010-11. Further, a second shift M.Tech. Course in Control Systems in the EEE Department was also started. Also the members were informed that proposals for new UG/PG courses to be introduced in MREC during the academic year 2011-12 were made to the AICTE. The AICTE has sanctioned first shift M.Tech. Course with an intake of 18 in Computer Science & Engineering in the Department of Computer Science Engineering for the academic year 2011-12. The AICTE has also sanctioned an Undergraduate course B.Tech. (Information Technology) in the Department of Information Technology with an intake of 60 for the academic year 2011-12. Decision of the AICTE is awaited for the other proposed courses. These courses will commence from the year 2011-12 after receiving approval from the AICTE. In view of the above,

Resolved that the action taken by the college in regard to the proposal for new courses during 2010-11 and 2011-12 both at the UG and PG level be ratified.

- 2. The principal informed the members that an application made to the JNTU for according permanent affiliation to MREC was approved by the JNTU. The College was granted affiliation for a period of three years.
- 3. The members were informed that an application was made to the JNTU for granting Autonomous status to MREC in view of its long standing and progress made during the last few years in April this year. Consequently, starting from the academic year 2011-12 the college is granted autonomous status on a trial basis for one year subjected to review after this period. Hence

Resolved that the administration of the college may initiate all the necessary formalities and take suitable steps as may be fitting for making this college totally autonomous.

4. The members were informed that the NBA accreditation for the departments of EEE, ECE and Mechanical Engineering expires on 19th July 2011. Further all other Departments have qualified for going for accreditation. Hence, Principal requested the members to authorize the Principal to make application for accreditation for all the existing seven departments. The matter was discussed and resolved that the Principal take all the necessary steps to apply for NBA accreditation for the Departments of EEE, ECE, Mech., Civil, CSE, MCA and MBA to the National Board of Accreditation, of the AICTE immediately.

- 5. R and D activities pertaining to the Nano Technology Research Centre were briefed to the Members.
- 6. A Request was made by the principal to approve the list of ratified staff of MREC and also the list of staff selected by the MRGI staff selection committee.

Accordingly, it is resolved that the list of staff ratified by the JNTU be approved.
