- II. The Principal has given a power point presentation covering the following points:

- III. The members after review have ratified the following:
  1. The members have noted with satisfaction on the progress and action taken on the resolutions of the governing body meeting of 27<sup>th</sup> October, 2012.
  2. The minutes and resolutions of the academic council meeting held in Malla Reddy Engineering College on 23<sup>rd</sup> August, 2013 for the academic year 2013-14
  3. Minutes and resolutions of Board of Studies in English/Physics/Chemistry /CE/CSE (including IT &MCA)/ECE/EEE/ME/Mining Engineering for the academic year 2013-14.
  4. The budget proposal for 2013-14 with:

a) Expected income	: Rs 198,385,000

5. The members have noted that a total of 29 research papers have been published by MREC faculty and appreciated their efforts in this regard. To promote research culture among the young faculty members, from this academic year onwards, it is resolved to offer the following incentives:

- Publication of Research papers in peer reviewed International journal : Rs 5,000/-
- Paper presentation in International conference :Rs 5,000/-
- Publication of Research paper in National journal :Rs 2,000/-
- Paper presentation in National conference :Rs 2,000/-

IV The members have discussed the academic/administrative issues and the following points have come up during the deliberations:

1. The members appreciated the finishing school concept introduced in MREC and have suggested that the college should be a TREND setter in all academic matters for other colleges of MRGI.
2. MREC should initiate all necessary steps to improve the Intake quality of students.
3. MREC should seek to build up an R&D fund from internal resource generation which helps to improve the ranking of the college.
4. The college should establish a centre of excellence with an incubation centre to improve the research & development activity.
5. The college should take all necessary steps to improve industry-institute interaction.
6. The college should take all necessary steps to minimize the academic wastages.
7. The college is to consider the feasibility of initiating "CHAIR" for selected industries in consultation with them.
8. The college should improve the Audio & Video system in the auditorium.
9. The college is to take special steps to improve the communication skills of the students to improve the placement opportunities after the completion of the course.
